3. Summary in English and Swedish – About 15 lines on the Steering Group -- activities, results and conclusions.

The Steering Committee is composed of politicians and officials who have an interest in the area and have extensive networks related to the area. They will closely follow the work during the time of the project. In addition to the stipulated meetings twice a year, the steering group in respective country, if necessary, will also act as a speaking partner and guidance body during the project. Some of the members in the steering group will also be involved in the project and be bridges to other stakeholders such as Universities, which are represented, in both the Vietnamese and Swedish part of the steering group.

The Steering Group are responsible for connecting with the steering group in Pitea, managing the implementation of the project's activities under the commitment with ICLD. In 2018, the parties met, once in An Giang (in March 2018) and once in Pitea (in September 2018). In December 2018, both parties also reviewed and evaluated the set objectives achieved in 2018 and planned for activities in 2019.

The Covid-19 pandemic affected some activities of the project. The An Giang – Sweden Project management Unit (PMU) and other project groups reported implementation progress and problems to the Steering Committee and the Monitoring group. Then they have met to assess the level of influence and gave solutions.

The PMU discussed with project leaders (Mr. Bo Wiberg) and steering group of Piteå. Coordinator also sent email to ICLD to ask guidance which then was translated into Vietnamese and forwarded to all project members. ICLD decided that the project could be prolonged to May 31, 2023.

As a result, the set objectives under the commitment with ICLD involved in the organization and implementation of the Steering Group were conducted in a timely manner. The effectiveness of the project was raised and extended in accordance with the objectives of the action plan.

4. Background – Briefly describe the background of the partnership (*must relate to the background text in the application*).

The partnership started with a visit from a Vietnamese delegation to Sweden in 2010 when a representative from Piteå met with them at an energy conference and presented the ongoing work carried out in this area in Piteå. The interests from both parties matched. This resulted in the project "Piteå - An Giang sustainable municipalities" (Dnr.2011-0110 + 2011)

and the project "Action plan for utilizing rice waste" (Dnr.2014-0065+0063). There was also an interest in Piteå to work in this area in a more global perspective.

To submit a new application is a result of the ongoing work due to that are more things that need to be done and we can utilize the gained experiences from these past years. From the target groups in Vietnam, it is expressed a need of having a new project in order to take further steps towards the implementation of the action plan.

5. Results

a) Describe the extent to which the Steering Group was able to support the Project(s) in one or more of the four ICLD core areas. For example, support refers to new or developed policies/expression of will/decisions/steering documents in the international partner municipality:

• Equity/inclusion

The implementers of Steering Monitoring committee (SC) and Monitoring committee (MC) were chosen based on their knowledge, capacity, skills, experiences, responsibilities and availability. The core group are also been part in the ongoing project and gained valuable experiences during these years. They are not discriminated against in terms of gender, religion, ethnicity, property, etc.

All ideas were respected and reviewed from the very beginning as writing new proposal, building detail plans or writing reports. Information and reports of the project were sent to all project participants and uploaded on the website of the project so anyone could access and followed what have been done.

Steering Committee and Monitoring Committee members are both government officials and politicians. Therefore, they can make changes in policies or propose policy changes to the Central Government (at congress meeting).

Politicians of An Giang province decided and asked all Departments, local authorities to invite citizens in areas for getting ideas, comments for new decision on policies, strategies and planning.

Citizens are free to raise questions and require explanation from politicians and officials. All People's Committee and Departments allocates one day to welcome citizens, answer queries and handle complaints of citizens directly (school fees of their children, land disputes, wage policies, etc). They contact with leaders of related agencies and express their point of view and that is what happening in entire political system of An Giang.

An Giang PPC (SC) also developed website that is updated news, new decisions, new political documents, working schedule of each agency/department/people's committee so everyone can access information and know who take responsibility.

• Participation

As the top unit of An Giang, leaders of People's committee of An Giang province (PPC) have been members of the partnership from 2012. In An Giang, they have had a big steering committee for two partnerships (Piteå and Vaxjo) including many leaders (politicians) from People's Committee, Departments of local authorities. Head of that is top leader of

An Giang province. They met two times per year to ensure that municipal partnership program can get objectives as well as contribute into agenda 2030. In which there is specific groups in charge of Piteå and An Giang partnership.

Besides, there is core group of the project. It is monitoring committee including four members who are chosen based on specific criteria in accordance with their qualifications, professions, project management capacity, the knowledge of Vietnamese laws and regulations. These four members are the provincial chosen representatives whose work monitored by the provincial people committee of An Giang.

• Transparency

From the beginning of the partnership program project members of both sides were extremely straightforward and transparent in sharing information. Members are selected to participate and clearly assigned from the beginning via meetings and administrative documents. in An Giang, the Project Management Unit, the Steering Committee, Monitoring Committee and the consulting group as well as other project members are assigned specific tasks in writing (Decision of the Provincial People's Committee). Most of the participating members have joined the project since 2012 and are all government civil servants. Implementing and ensuring transparency is also political mission and responsibility of each individual.

All information is publicly available (costs, resources, difficulties, advantages, ...). The project management Unit jointly coordinates and proposes and reports progress to project members for discussion, so that all members know about project activities and decisions.

The counterpart funds of the An Giang project are allocated and strictly managed in accordance with the law. The progress and results of project activities must be summarized and reported to the Provincial People's Committee, Steering Committee, Monitoring Committee and other project members in writing according to regulations. All information of planning and detailed activities were openly discussed and build from contribution of all project participants and target groups via internal meetings.

The steering committee has practiced transparency from planning to implementing process. Project members of An Giang province have publicly announced the strengths and weaknesses of the province to discuss together when writing new project outlines. Challenges and lessons learned are very interested and shared honestly at the monitoring group meeting, especially policies to ensure democracy and transparency in the project.

Vietnam has laws to fight corruption and promote democracy and transparency. As the leader, also the politician and the steering Committee's member, they actively disseminated the Central policies to each agency and staff. Transparency about information and changes in dialogue with citizens has been increasingly concerned. Politicians came to each commune for meeting with citizens. It is one of the duties of the delegates of the People's Council, as stipulated in the Law on Organization of the People's Council and People's Committee. The People's Council deputies through local authorities organized meetings with local citizens to collect opinions, listen to their thoughts and wishes. Doing well the meeting with citizens, promptly solving legitimate opinions, recommendations, aspirations and frustrations of them will contribute to maintaining political stability, social order and safety in the locality. At the same time, enhancing the role and position of People's Council deputies, thereby improving the performance of People's Councils at all levels. Besides, all recommendations, thoughts and aspirations of citizens were recorded by the local authorities and submitted to the Provincial People's Council at meeting sessions.

In the project, reports were synthesized by the authorities and sent to all project members, departments, provincial People's Committees and publicized to all citizens. Agencies assigned are responsible for evaluating and monitoring each other to achieve common goals

• Possibility to demand accountability

Provincial People's Committee (PPC) has signed the decision to establish groups in charge of cooperation program between An Giang and Sweden. This includes clear assignment for each individual and unit to be responsible for each project. This is an administrative document and has political effect. With the transparency of this decision, departments, state agencies and local authorities know exactly who is responsible for what during the project implementation.

The decision of establishing project participation states that the PPC is line agency the An Giang and Piteå Partnership program and has main responsibility for the project. Leaders of PPC identified responsibilities for different department and units in order to get committed objectives. The An Giang – Sweden project management unit (PMU) is main implementing agency. There were official decision regarding establish the steering committee, monitoring group, assistant group and An Giang – Sweden Project Management Unit. The PPC issued it and sent to all Departments, units of An Giang. The PMU is also a main focal point agency for collecting and review information, aggregate reports, coordinate with the project team and other agencies to develop detailed activity plans.

The Steering Committee is responsible for helping the Provincial People's Committee orientate mechanisms, policies, plans as well as direct, supervise and inspect the Departments, branches and localities to effectively implement the programs.

The personnel involved in the implementation of the projects within the An Giang and Sweden Partnership Programs are responsible for helping the Steering Committee to build a specific implementation plan for projects and propose solutions to implement projects. In particular, the Advisory Board supports and assists the Steering Committee in connecting, implementing and proposing cooperation projects in a feasible and effective way.

The Steering Committee, the Monitoring group, the An Giang – Sweden Project management Unit (PMU), the Assistant team and other related agencies to the An Giang – Sweden Program operate under the Regulations signed by the Provincial People's Committee. All groups will be self-dissolved after completing the program timeline.

b) If possible, provide concrete examples of what took place on an organisatory level.

• In An Giang:

This project's Steering committee and Monitoring committee are mostly composed of members who have been involved since the beginning of the project. The changes in participants are due to the change in position and retirement. This is to ensure the continuity of the projects from 2012 to the present and is also the commitment and support of the leaders of An Giang province for the implementation of the project's goals.

For example: Process of adjusting activity plan of the project in An Giang

The Covid-19 pandemic affected to some activities of the project. The An Giang – Sweden Project management Unit (PMU) and other project groups reported implementation progress and problems to the Steering Committee and the Monitoring group. Then they have met to assess the level of influence and gave solutions.

The PMU discussed with project leaders (Mr. Bo Wiberg) and steering group of Piteå. Coordinator also sent email to ICLD to ask guidance which then was translated into Vietnamese and forwarded to all project members.

After internal discussion/meetings in An Giang and Piteå, they set up online Steering group meetings in June and December to finalize information and give common decisions. Secretary of the meetings remarked all main information and prepared minutes in both Vietnamese and in English which sent to all participants to review before getting them signed by Chairwoman of the meetings (Brith Fäldt). The final step is main task of the An Giang – Sweden Project management Unit. They must submit an official letter to the PPC to ask for approval on prolonging timeline and revised activity plan of the project. After receiving the official letter listed full of information what and why, Ms. Lý Thị Thanh Tuyến, Deputy Head of Economic Division, Office of the PPC - members of Assistant team of the An Giang-Sweden programs should report to Mr. Trần Anh Thư, vice chairman of People's Committee of An Giang province for decision. The decision will be issued by the PPC and sent to all groups in An Giang – Sweden partnership programs, Department, local authorities and related agencies to know and support for implementation.

• Example of making a decision to add more content in the project plan in An Giang

The project teams from both sides discussed the progress of the information dissemination workshop in the last year of the project. They realized it was better to have video clips and evaluation reports for the whole collaborative process instead of just disseminating information for the current project. After this discussion results will be sent to SG members of both sides (through the SG meeting) for consideration and final decision. Based on the general agreement of SG, the Department of Natural Resources and Environment of An Giang

province sent an official letter to the People's Committee of An Giang province with the goal of allowing additional contents to be added to the project to get more funding for implementation. After obtaining the written permission of the Provincial People's Committee, the Department of Natural Resources and Environment and the Department of Finance will discuss and determine the funding to be allocated to the PMU.

• Example of changing members in SC or MC:

The individuals participating in the SG and MC are assigned a written Decision - approved by the People's Committee of An Giang province. Th**erefore**, when there are members of the executive committee, the supervisory board changes positions that are no longer relevant to manage the project or they retire. The members will discuss to each other to propose suitable new members, ensuring that this new member also has an understanding of the project as well as a commitment to support the project. Based on this proposal, the Department of Natural Resources and Environment of An Giang province (and PMU) sent a document to the Provincial People's Committee to sign a new decision to adjust the participants.

During the Covid-19 pandemic, businesses and people faced many difficulties in production and trading. The economy of An Giang province in particular and Vietnam in general was also affected. Women, small business and small farmers in rural areas were concerned by project staff. They were reminded by farmers about a proposal to adjust the models of using straw. Instead of continuing to support the model of collecting straw by machine, the project should help people implement program of making organic fertilizers from the waste of growing mushrooms. It was a good suggestion because both increasing the value chain of by-products and helping people increase their income locally. Therefore, the PMU reported to members of the steering committee and got approved by the PPC. Coordinator continued to work with Department of Finace to reallocate the project budget according to the revised new activity plan. Detailed plan for implementation was discussed with local authorities and technical teams. An official notification listed all information of each program (objectives, contents, support materials), timing, criteria, etc were sent to all districts and towns in An Giang province for inviting suitable participants. After that, it was the stage of synthesizing the list, meeting the registrants and organizing knowledge training, handing over supporting materials from the project to the people. The Steering Committee and the

project members have the right to monitor the activities and can visit farmers for checking whenever they want to. Training classes, technical documents are shared publicly on the media. The results of the programs, difficulties and recommendations of the people on how to implement the models effective were acknowledged by the implementers for improving better in the new project.

Through above example, members of the steering committee and the monitoring group have listened to opinions of the people from the local level. Thereby, the role and capacity of the people are increasingly enhanced and contributed into turning waste into green products. In other hand, responsibilities of implementers and stakeholders are clarified information and transparency brought participants' confidence and trust. The good results continued to spread to other localities and benefited many people.

e) Describe how the Steering Group has worked to guarantee the integration of gender equality, environmental and human rights into each project.

In An Giang there are 12 members in the SC and 4 members in the MC. Each member of SG and MC is a civil servant and also a leader representing their agency participating in the project. Women's participation in leadership is encouraged. The project prioritized inviting female officials from departments to participate in different groups in the project.

The SC has had two formal meetings yearly, one in each country. However, this year they had distant meeting due to the Covid-19 pandemic. There were in Sweden only formal members have participated in the meetings but in Vietnam there have been many more participants who also have contributed to internalizing and acceptance of the project.

In An Giang, the objectives of the project are in line with Vietnam Comprehensive Poverty reduction and Growth strategy. It means that results of the project contributed into provincial achievement for poverty reduction, especially in rural and remote areas.

Through supporting models of rice straw utilization in rural areas and information sharing and capacity building workshops, farmers have stopped burning paddy straws which caused environmental pollution. Youngsters, women farmers and enterprises have encouraged to attend trainings, workshops, fieldtrips. People in rice communities now have earned more money from utilizing straw programs of the project. It helps them afford their children school fees and living life. It is not uncommon to see straw rolling machines in paddy fields and a lot of new models are implementing at other districts. In addition, SG and MC always remind the project team about gender equality criteria in all project activities (models, trainings, workshops, study exchanges, etc).

6. Support, quality assurance and management of the partnership

a) Describe the internal anchoring process. Who in the municipalities has been involved, how has knowledge of the partnership been spread, who has made decisions in regards to the partnership, what parts of the municipality are involved in the partnership?

To implement the project, An Giang province has mobilized leaders of the Provincial People's Committee, leaders of departments, universities, local authorities as well as civil servants at all levels to participate in the project. They have Steering committee, Monitoring committee, project management team, working group, communication team and team of consultants. This is a great resource and contributes greatly to the success of the project. In which, there is a Monitoring committee with expertise in project management cooperation between An Giang and Piteå. The four members of the monitoring committee in An Giang are the representatives from Provincial People's Committee, Department and University with at least 50% is women.

Every year, the SG and MC discussed to develop plans, agendas, and objectives to be achieved under the commitment via meetings, emails, phone. SC and MC members receive monthly project progress reports from the project team. From there, they can evaluate the project's goals and make adjustments (if necessary) to ensure the most effective implementation of the activity plans.

Except for project meetings, SG and MC members also regularly check and manage project-related tasks assigned to their agencies by the Provincial People's Committee. At these meetings, members of SG and MC also informed the results and progress of the project to their staffs.

For example, the Department of Agriculture and Rural Development will update information on the situation of rice straw use in the districts, especially in Chau Thanh district where the project's models are being implemented. The Department of Finance must also manage the disbursement of funds for project activities.

b) Describe how the Steering Group has worked to monitor the Project(s)' quality and progression.

This process is almost the same since 2018 accept that meetings in 2020 -21 was carried out on-line via Teams.

SG and MC manage project objectives through monthly reports from PMU as well as meetings.

The leader of SG and MC - Mr. Nguyen Thanh Binh and later Mr. Tran Anh Thu is also the leader of the Provincial People's Committee - the agency that manages and is responsible for implementing the project's commitment to the project partners and sponsors. The participation and support of SG and MC is the highest guarantee for the determination in the cooperation program. Therefore, when SG members make a decision related to the project, it means that it is a decision from the government agency of An Giang province. Subsequent administrative procedures are a way of legalization. The involvement of government leaders in SG and MC helped the project to be closely managed throughout the implementation process. Changes in the project plan whether big or small are quickly resolved, problems are also handled promptly to achieve the project goals.

For example, the old project website's domain (angiang-sweden.com) expired in 2020. However, PMU proposed a website to publish project information. Therefore, SG allowed to add budget for new website (angiangpitea.com).

The leader of An Giang -Sweden Project Management Unit, a member of the Steering Group, mainly responsible for the activities of the project, regularly informs the entire project implementation progress to other members in the Steering Group. The top leadership of An Giang provincial government, directly participates in project management, as the leader of SG and MC. From there, SG has the right to direct relevant agencies and individuals to the project's activities to ensure the project achieves the best possible results. Compliance with commitments creates trust between two partners An Giang and Piteå. on the contrary, the support and participation of the leaders of An Giang province is rooted in the close friendship since the beginning of the cooperation program. This is a reciprocal process and creates a friendship, trust and joy in the execution of the project. The project members not only see the project as a mandatory task but also consider it a favourite thing when meeting and discussing with Piteå friends. Especially during the Covid-19 epidemic, project members were very worried about each other's health and missed each other when they could not hold the annual meetings. During the process of contact and work, there was cultural exchange and sharing of views in different fields such as society, environment, education and even family life.

The seriousness, transparency and democracy of Pitea has helped create the working style and decision-making of An Giang province. Steering group members are not subject to barriers in leadership positions in the government system. The members can meet in person, at meeting, contact via email, or phone call. Similar situation with both partners.

When Mr. Peter Roslund- the former mayor of Pitea invited the An Giang delegation to watch the football match, everyone lined up and had to stand because there was no seat due to being late. They did not have any priority for leaders/politicians. It is an expression of justice and democracy in life. Or equality and democracy in the way of exchange and decision-making in the SG of Piteå. At that time, the project members of An Giang side were very surprised but felt it should be like that.

According to project coordinator from An Giang's side, she thinks that mutuality is what we can learn and support to each other. Piteå has supported An Giang and vice versa. In An Giang, each SC member and project members also gained benefits from the partnership. All above that, she learnt that we are successful since we feel secure that both partners trust and being trusted by members of the partnership. We are equal in discussion and always feel free to give comments for contribution, and are approximately equal in our energy for staying in the project together. There are some major areas of mutuality that we learnt over the years; partnership and friendship is to succeed and grow; love, benefit, trust and support.

An Giang's side have learnt a lot of good things from the SC and MC members in Piteå's side. We are like a big family. We always look forward to seeing each other and working together. During meetings and discussions, we had new ideas to develop not only the project's activities but also to have motivation and inspiration to test new models in An Giang to improve value business incubation model.

Leaders of People's committee in provincial levels, district levels have been enhanced capacity on agricultural wastes and bio energy from rice by-products. Voices of roles of women, especially women famers have been be paid attention to. Technicians had chance to enhance new knowledge and experience from experts of Piteå.

Whenever we had problems in implementation of activities, we informed steering group members in An Giang and in Piteå. They never criticize but just finding out the cause and giving the best solution.

An Giang and Piteå have different political system but we have learnt from each other good strategies and planning. Steering group members approved strategy plan as well as action plan of turning rice wastes into energy for An Giang province to 2030. It is important political decision to turn An Giang into green rice communities in Mekong Delta. And that is result of mutual partnership.

The Covid-19 pandemic caused the project's activities to be postponed, so the project's time had to be extended. This causes the cost of salary payment for the Project Management Board (2021-2023). SG and MC members expressed their support and maintenance of the project as well as supporting the procedure for the Provincial People's Committee to sign a decision to extend the implementation time as well as provide additional funding.
